CANCELLATION POLICY

Englewood Lighthouse Resort would like all of our guests to be able to cancel their plans if the need arises.

A Seasonal Guest (Any stay dates between Feb. 1 through April 15) who desires a cancellation must notify Englewood Lighthouse Resort, in writing, prior to 45 days before the check-in date to receive a refund. All refunds will be assessed a 15% fee of the total bill. No moneys will be refunded if the cancellation is less than 45 days prior to the check-in date.

An Off-Season Guest (No stay dates between Feb. 1 through April 15) who desires cancellation must notify Englewood Lighthouse Resort, in writing, prior to 7 days before the check-in date to receive a refund. All refunds will be assessed a 15% fee of the total bill. No moneys will be refunded if the cancellation is less than 7 days prior to the check-in date.
